**Program Goal**: This session will highlight best practices in responding to patients/clients who experience domestic or sexual violence by reviewing the components of a Sexual Assault Nurse Examiner (SANE) exam, what it means when a hospital becomes a SANE site, and the role of local domestic and sexual violence response agencies. The critical role of health and human service professionals in recognizing, responding with care to, and referring patients/clients will also be discussed, as will the role of medical interpreters during a SANE exam.

**Target Audience:** This workshop is designed for healthcare professionals of all levels working with patients or clients who have experienced domestic violence or sexual assault.

### **Learning Objectives:**

At the end of the program, the participants will be able to:

- 1. Recognize the MA sexual assault nurse examiner statewide program.
- 2. Describe what it means to be a designated SANE site.
- 3. Summarize the criteria for having a SANE exam.
- 4. Describe what it means to provide trauma informed care.
- 5. Recognize the role of the Elizabeth Freeman Center in responding to domestic and sexual violence.
